Documentation for SOY CONCENTRATE Product(s) Used as Alternate Protein Products (APP) for Child Nutrition Programs

- a. SOY CONCENTRATE certifies that ARCON T 158-171 meets all requirements for APP intended for use in foods manufactured for Child Nutrition Programs as described in Appendix A of 7 CFR 210, 220, 225, and 226.
- b. SOY CONCENTRATE certifies that ARCON T 158-171 has been processed so that some portion of the non-protein constituents have been removed by fractioning. This product is produced from soybeans by removing the majority of the soybean oil and some of the other non protein constituents.
- c. The Protein Digestibility Corrected Amino Acid Score (PDCAAS) for ARCON T 158-171 is 0.99. It was calculated by multiplying the lowest uncorrected amino acid score by true protein digestibility as described in the Protein Quality Evaluation Report from the Joint Expert Consultation of the Food and Agriculture Organization/World Health Organization of the United Nations, presented December 4-8, 1989, in Rome, Italy. The PDCAAS is required to be greater than 0.8 (80% of casein).
- d. The protein level of ARCON T 158-171 is at least 18% by weight when fully hydrated at a ratio of 3.6 parts water to one part product.
- e. The protein level of ARCON T 158-171 is certified to be at least 64.8 % on an "as-is" basis for the as-purchased product.
